# COLD OR FLU

## KNOW THE DIFFERENCE

The flu and a cold can have similar symptoms. The difference is how intense they feel and how common they are. In general, symptoms of the flu appear quickly, while symptoms of a cold happen slowly.

### COLD

You may feel chills but fever is rare

Cough, chest discomfort  
(mild but may last a while)

Body aches & pains  
(mild)

Tiredness  
(you can still do your daily activities)

Headache  
(mild)

Sore throat

Stuffy, runny nose, sneezing



### FLU

Fever

Cough, chest discomfort  
(dry cough can be severe)

Body aches & pains  
(can be severe)

Bedridden  
(you may feel extremely exhausted)

Headache  
(can be severe)

Sore throat

Stuffy, runny nose



### COMPLICATIONS CAN INCLUDE...

- + Lung infections
- + Throat infections
- + Ear infections
- + Sinus infections

### COMPLICATIONS CAN INCLUDE...

- + Pneumonia
- + Pre-existing health conditions getting worse (such as asthma)
- + Hospitalization
- + Death

# KNOW THE FLU FACTS

## THE FLU CAN BE SERIOUS.

- + The flu is very contagious and can spread **quickly** and **easily**.
- + Before you even know you are sick, you can **pass the flu on to others**.
- + In Canada, an average of **12,200 hospitalizations** and **3,500 deaths** related to the flu occur each year\*.

## THE FLU CAN AFFECT ANYONE.

- + Even healthy people can get the flu, and it can be serious.
- + People at **higher risk of serious complications\*** are:
  - > adults aged 65 and over
  - > young children
  - > those living with one or more chronic health conditions
  - > pregnant women
  - > those residing in nursing homes or other facilities
  - > Indigenous peoples

## YOU NEED TO GET VACCINATED EVERY YEAR.

- + **Flu viruses** change each year. Experts create a **new vaccine** to protect you **each flu season**.

## YOU CAN'T GET THE FLU FROM THE FLU SHOT.

- + The viruses in the **flu shot** are either killed or weakened and **cannot give you the flu**.

## THE FLU SHOT IS SAFE.

- + **The flu shot** has **benefited millions** of Canadians since 1946.
- + Most people don't have reactions to the **flu shot**; those who do may have soreness, redness or swelling at the injection site.
- + **Severe reactions** to the vaccine are **extremely rare**.

## EVERYBODY WINS WHEN YOU GET VACCINATED.

- + If you do get the flu, the **flu shot** may reduce the **severity of your symptoms**.
- + By getting the **flu shot**, you **protect yourself and others** because you are less likely to spread the flu.
- + It's a **simple action** that can **prevent complications** and **save lives**.

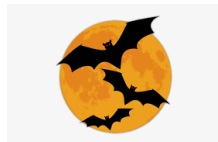

## SAFE DRINKING WATER MONITORING PROGRAM

### Community Based Drinking Water Quality Monitoring Program

Community Based Drinking Water Monitors (CBWM) play a key role in the Drinking Water Safety Program as the designated person responsible for sampling, testing, recording and communicating the microbiological quality of drinking water within the community. The CBWM is also responsible for distributing results and may assist with developing and carrying out a drinking water quality awareness program.

The CBWM may be a Community Health Representative (CHR), Water Treatment Plant Operator (WTPO), or another individual selected by the Band. If a community does not have a CBWM, the activities may be completed by the FNHA Environmental Health Officer or an FNHA Environmental Health Technician. Environmental Health Officers train CBWMs to sample and test the drinking water for potential microbial contamination using community lab equipment (Colilert®).

WaterTrax®, an internet-based data management system, is used to securely manage all drinking water quality data to which the CBWM, Band Health Directors, and the Drinking Water Safety Program (DWSP) team have access

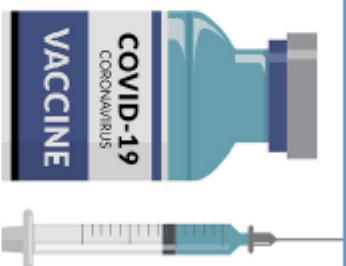

## Announcing MOA Director Dr. Susan Rowley

The Museum of Anthropology is delighted to announce that the University of British Columbia has appointed Dr. Susan Rowley to a three-year term as Director of MOA. Dr. Rowley has served as Acting Director since July 1, 2021, when Dr. Anthony Shelton completed his third term as Director.

Sue, as she is known to her colleagues and friends, is a Curator at MOA and an Associate Professor in the Department of Anthropology, two roles she has served in with passion and curiosity since joining the UBC community in 2001. Originally from Ottawa, Sue holds a PhD in archaeology from Cambridge University. Her research



extensively with Inuit elders on historical research and with Inuit youth on archaeology projects. Through her work at MOA, she collaborates regularly with Musqueam and other Indigenous communities in British Columbia on exhibitions, training initiatives, and research projects.

“Musqueam has been working with Sue for many years through various initiatives, and I’m pleased to now welcome her in the role of MOA’s Director,” said Leona Sparrow, Musqueam liaison to MOA and UBC. “Sue is respected for her deeply held relationships and her collaborative style. She is a strong leader for MOA.”

Sue serves as the long-time Chair of MOA’s Repatriation Committee, which most recently facilitated a request for the return of a Haida mortuary pole in 2018. She has curated several major exhibitions at MOA, including [The Fabric of Our Land: Salish Weaving](#) (2017/2018) and the award-winning [čəsnaʔəm, the city before the city](#) with co-curator Jordan Wilson (Musqueam) (2015/2016).



In 2019, Sue was instrumental in supporting the development of the [Indigenous Internship Program](#) at MOA, a joint initiative with six Indigenous partners: the Musqueam Indian Band, the Squamish Lil’wat Cultural Centre, the Haida Gwaii Museum, the U’mista Cultural Society, the Nlaka’pamux Nation, and the Coqualeetza Cultural Society. The Indigenous Internship Program provides training opportunities for Indigenous people already working in museums and cultural centres or intending to do this kind of work.

Sue also serves as Co-Academic Coordinator for Musqueam 101, an ongoing speaker series hosted by Musqueam in partnership with UBC. The program builds greater cross-cultural understanding of Musqueam’s rich cultural and historical legacy, and provides an opportunity for visiting scholars to engage with Musqueam community members and for community members to meet educators and participate in the academic culture of UBC.



During MOA’s Partnership of Peoples expansion project, completed in 2010, Sue served as one of the leads for the creation of [the Reciprocal Research Network](#)

collections around the world, with a focus on First Nations heritage from the Northwest Coast and British Columbia. The RRN was co-developed with the Musqueam Indian Band, the Stó:lō Nation/Tribal Council, the U'mista Cultural Society, and UBC's Laboratory of Archaeology (LOA). As part of the Partnership of Peoples project, moreover, Sue oversaw the development of a suite of research labs for LOA within the Museum.

Sue is a dynamic teacher who, in addition to her curatorial work at MOA, mentors and supervises PhD and MA students. She teaches the popular Museum Practice and Curatorship course to undergraduates—a course that is taught at MOA and provides practical hands-on learning in different areas of museum work. Her major service roles have included Director of LOA, Chair of the Anthropology Graduate Studies Committee, and Co-Head of the Department of Anthropology.

“Through her many contributions to MOA and the Department of Anthropology over the years, Dr. Rowley has demonstrated her strengths in a range of administrative and leadership roles, and she has garnered the trust and respect of her colleagues and members of the Indigenous communities with whom she has worked for many decades,” said Dr. Gage Averill, Dean of the Faculty of Arts. “I am confident that the combination of administrative experience, strong interpersonal and leadership skills, and deep understanding of and engagement with the issues facing the Museum will equip her to be successful in carrying out the responsibilities of the Directorship and in bringing MOA closer towards the fulfillment of the commitments it has made to [the United Nations Declaration on the Rights of Indigenous Peoples](#) and [the University's Indigenous Strategic Plan](#).”



Critically, Sue will lead MOA through a period of major transition as the Museum undertakes several significant endeavours in the immediate term: recovering visitorship and revenue following the COVID-19 pandemic, undergoing seismic

Sue was appointed at the conclusion of an international search, on the recommendation from the advisory search committee, which was comprised of community members from Musqueam, student and faculty representatives from the departments of Anthropology, First Nations and Indigenous Studies, Political Science, and History, as well as MOA staff representatives.

"I am honoured and humbled by this opportunity to further develop MOA's history of



working with Indigenous partners and originating communities around the world," said Sue. "I look forward to working with the dedicated team at MOA as we review our policies and procedures and implement BC's Declaration on the Rights of Indigenous Peoples Act as well as UBC's Indigenous Strategic Plan. I am

also committed to developing and strengthening MOA's relationships with the many peoples and communities engaged in the Museum's initiatives."

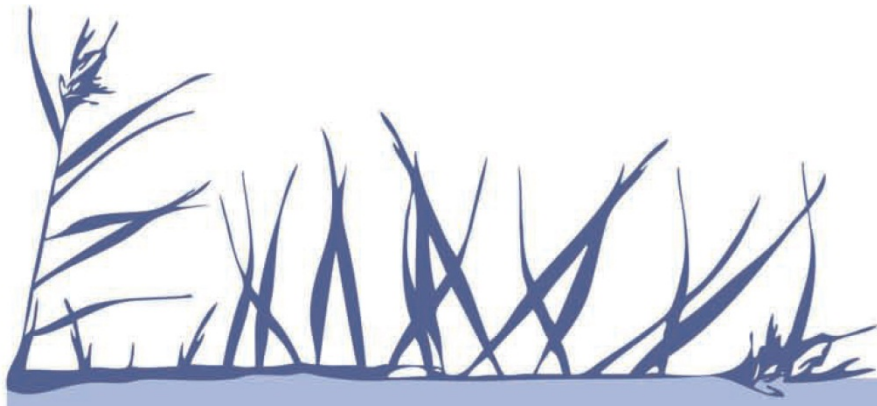

### **Musqueam Land Code Committee - Request for Expression of Interest**

The Musqueam Land Code Committee of Council invites a letter of expression of interest from any Band Member interested to be considered for an appointment to serve on the Musqueam Land Code Committee.

The Musqueam Band Council is the deciding body as to who will be selected for the committee that is comprised of a total of seven members.

There are four people required to be appointed:

- **Two Musqueam Band Member at Large;**
- **One Musqueam Band Youth Representative;**
- **One Musqueam Band Elder Representative.**
- The Committee are core to supporting Musqueam Lands Governance in the execution of their committee duties to follow the Terms of Reference; ensure financial statements are prepared per Lands activities; Ensure Audited financial statements are prepared and provided to Band; Report to Members lands activities; review: draft laws; lands applications; development applications for consideration and recommendations to Chief and Council and are supported by MLGO staff and legal advisors, Murray Browne, Legal Land Code Consultant and Melissa Louie, Musqueam General Counsel

### 1. Introduction

- 1.1 Musqueam Indian Band passed the Musqueam Land Code dated for reference June 28, 2012 in accordance with the Framework Agreement on First Nation Land Management between Musqueam Indian Band and Canada and ratified on behalf of the Government of Canada by *the First Nations Land Management Act*, S.C. 1999 c.24.
- 1.2 The Musqueam Land Code came in to effect on June 5, 2017.
- 1.3 The Land Code established a **Lands Committee** under section 24 and subsection 24.4 states that:  
“The Lands Committee may establish rules for the procedure at its meetings and generally for the conduct of its business matters, not inconsistent with those established by Council.”

### 2. Lands Committee Mandate

- 2.1 The Lands Committee’s mandate under subsection 24.1 of the Land Code is to:
  - (a) assist with the development of the land administration system;
  - (b) advise the Council and its staff on matters respecting First Nation Land;
  - (c) recommend to Council Laws, Resolutions, policies and practices respecting First Nation Land;



- (d) hold regular and special meetings of Members to discuss land issues and make recommendations to Council on the resolution of these land issues;
- (e) assist in the flow of information on land issues between Members and the Council; and
- (f) oversee community approvals under this Land Code.

2.2 The Lands Committee also has a role under the Land Code in the following areas:

- (a) making recommendations or proposals for laws relating to lands (sections 6 and 7);
- (b) establishing a community process to develop and implement the core initial land laws referred to in subsection 11.1 and rules and procedures referred to in subsection 24.2 and presenting these to Council:
  - (i) land use planning and zoning;
  - (ii) transfers and assignments of interests;
  - (iii) setting rates, rents and fees;
  - (iv) environmental protection and assessment;
  - (v) disputes relating to lands; and
  - (vi) spousal property  
(subsections 11.2, 24.2, 24.3, 27.1, and 39.2);
- (c) making recommendations regarding proposed expropriations (subsection 15.7);
- (d) assisting in providing information to the community for any land exchanges that may be proposed (subsection 17.7);
- (e) avoiding conflicts of interest (section 18);
- (f) assisting in preparing or making recommendations for an annual report on lands to Members (subsection 22.1);
- (g) advising Council on the granting of interests, licenses and permits and, if delegated by Resolution, granting specified interests, licenses and permits (subsection 32.3);
- (h) making recommendations to Council on granting allotments or CPs (subsection 34.2);
- (i) granting rights of access onto Musqueam First Nation Lands if delegated (subsection 37.2);
- (j) appointing panelists to the Dispute Resolution Panel (subsection 40.3);
- (k) assisting to develop and implement annual work plans and budgets for the Lands Governance Office;
- (l) holding Committee meetings and other meetings to discuss issues relating to Musqueam First Nation Land and to make recommendations to Councils on the resolution of such issues;
- (m) assisting in the exchange of information between Committee members and Council;
- (n) assisting in coordinating meetings with Members in relation to the Land Codes;
- (o) assisting in reviewing applications under Land Code laws and making recommendations to Council;
- (p) taking reasonable measures to consult Elders with respect to matters in general under the Land Code, and particularly in respect of heritage lands and sacred lands; and

- (q) performing such other dues and functions as Councils may direct.

#### *Other Recommendations*

#### 2.3 The Lands Committee may recommend to Council:

- (a) policies for the remuneration and recovery of expenses incurred by Lands Committee members;
- (b) programs for the orientation and education of Lands Committee members;
- (c) amendments to these Terms of Reference;
- (d) laws, policies or procedures relating to Lands; and
- (e) amendments to the Land Code.

#### *Mainly Advisory*

#### 2.4 Unless otherwise expressly stated in the Land Code or in a delegation Resolution from Council, the role of the Committee is strictly advisory.

### **3. Lands Committee Appointments and Membership**

#### 3.1 The Lands Committee appointments, eligibility for appointments, terms and related matters are set out in section 25 of the Land Code.

*25.1. The Lands Committee shall be composed of 7 Members, including the chairperson, all of whom must be Eligible Voters.*

*25.2. Any Eligible Voter, whether resident on or off First Nation Land, is eligible for appointment to the Lands Committee, except for the following persons:*

- (a) unless waived by a Majority vote of those Eligible Voters present at a Meeting of Members, any person convicted of an offence that was prosecuted by way of indictment;*
- (b) any person who is an undischarged bankrupt or owes money to the Musqueam Indian Band; and*
- (c) any person convicted of a corrupt practice in connection with an election, including accepting a bribe, dishonesty or wrongful conduct.*

*25.3. The Members of the Lands Committee are to be appointed by Council as follows:*

- (a) two Eligible Voters;*
- (b) one representative of the Elder Community;*
- (c) one representative of the Youth Community; and*
- (d) the other 3 Members are to be members of the Council.*

### **4. Lands Committee Meetings and Recommendations**

#### 4.1 The Lands Committee will try to meet at least monthly and more often as necessary to fulfill their responsibilities.

#### 4.2 The quorum for a meeting is four (4) members.

#### 4.3 If a Lands Committee meeting has a quorum of members that passes the agenda for the meeting, and one or more members later leaves the meeting, the meeting may continue and

decisions and recommendations may be made provided there are at least three (3) members present.

- 4.4 Any Lands Committee meeting may continue without a quorum provided that:
- (a) notice of the meeting was sent to all Lands Committee members in accordance with this Terms of Reference; and
  - (b) no final decisions or recommendations are made at the meeting in the absence of a quorum.

#### *The Chair*

- 4.5 The Chair shall be appointed in accordance with section 26 of the Land Code. The Chairperson shall be chosen by the Lands Committee from among its members.
- 4.6 The Chair shall carry out the duties set out in the Land Code and generally assist in ensuring that agendas for Lands Committee meetings are prepared and followed and that the Lands Committee carries out its roles and responsibilities under the Land Code and these Terms of Reference.

#### *Notices, Agendas and Materials*

- 4.7 The Lands Manager shall ensure that:
- (a) an agenda and meeting notice are prepared for each Lands Committee meeting and circulated to Lands Committee members, along with any relevant drafts, reports or documents, at least one week in advance of each meeting;
  - (b) guests or advisors who are scheduled to be on the agenda receive the meeting notice, and their time on the agenda at least a week in advance of each meeting;
  - (c) a meeting schedule is developed, and revised if necessary, and Lands Committee members are notified at least one week in advance of each meeting;
  - (d) facilities and meals are arranged for each meeting; and
  - (e) any other necessary phone or video equipment is prepared and any other necessary arrangements are made for each meeting.

#### *Decisions and Recommendations*

- 4.8 All decisions and recommendations shall be determined by a vote on a duly presented and seconded motion.
- 4.9 Any Lands Committee member may request that the reasons for their abstention or opposition in a vote be recorded in the meeting minutes.

#### *Minutes*

- 4.10 The Musqueam Lands Governance Office will maintain minutes and provide the minutes to Committee members, with a copy to file, in a timely manner after each meeting.
- 4.11 Minutes will comply with Musqueam policies for all committees and, in addition, will contain:
- (a) the start time for the meeting;

- (b) a copy of the agenda, as amended;
- (c) an update or review of action items from past meetings;
- (d) a list of attendees at the meeting;
- (e) a list of any Lands Committee members who disclosed a potential conflict of interest or who left the meeting or abstained from participating in discussions or decisions;
- (f) all decisions or recommendations made;
- (g) a list of any proposed action items, along with proposed timelines and designated people;
- (h) the time of adjournment;
- (i) the proposed next meeting date; and
- (j) any other relevant information.

4.12 The Musqueam Lands Office will ensure that all Lands Committee members receive a copy of the previous meeting Minutes for review and comment. The Lands Manager will retain and archive Minutes in accordance with Musqueam Lands Governance Office policies and procedures and provide copies to the Lands Committee members at their request.

#### *Meeting Attendance*

4.13 All Committee members are expected to attend each Lands Committee meeting and if a Lands Committee member cannot attend a meeting, they will notify the Musqueam Lands Governance Office in writing.

4.14 If a Lands Committee member misses more than 3 meetings in a row without appropriate justification, the Lands Committee member will be removed and replacement will be appointed by Chief & Council.

4.15 Lands Committee members may also be invited to attend the following additional meetings but will not receive honoraria for these additional meetings unless specifically invited in writing to play a role in the meeting:

- (a) community meeting at which a Land matter is on the agenda for the community; and
- (b) community meeting or event organized and implemented by the Lands Committee,

4.16 Meetings may be in-person or via tele/video-conference.

4.17 The Lands Committee may invite First Nation officers, staff, guests, advisors or others to attend Lands Committee meetings as necessary.

#### *Training and Ongoing Education*

4.18 From time to time, external training opportunities, workshops or meetings regarding Lands may be made available; attendance by Lands Committee members to these events and any budget required must be approved by the Musqueam Lands Governance Office in accordance with the Lands budget approved by Council.

- (a) Attendance may be limited by availability of resources.



- (b) If attendance is approved, the attending Lands Committee members must:
  - (i) attend the full event, unless otherwise approved or directed by the committee or the Lands Manager;
  - (ii) participate in an effective manner; and
  - (iii) report back at a committee meeting directly following the event.

## **5. Oath; Confidentiality and Conflicts of Interest**

- 5.1 Each Lands Committee member shall sign an oath at the beginning of their term to confirm that they will act in accordance with the Land Code and this Terms of Reference.
- 5.2 The Lands Committee members must comply with the applicable provisions of the Musqueam Land Code and any other Musqueam laws or policies relating to maintaining confidentiality and avoiding conflict of interest.

## **6. Remuneration**

- 6.1 Lands Committee members will receive an honorarium in the dollar amount for each scheduled Lands Committee meeting in the amount as set by Council Resolution or policy.
- 6.2 Unless otherwise stated in a Council Resolution or policy,
  - (a) the honoraria shall be a fixed amount for each Lands Committee meeting including approximately two hours of preparation time and two hours of meeting time; and
  - (b) honoraria may be set at a higher amount for half-day or full-day meetings.

## **7. Amendments to Terms of Reference**

- 7.1 These Terms of Reference may be reviewed from time to time by the Lands Committee and amended as necessary if approved by Council by Resolution.
