ACCEPTANCE – To become a candidate, a nominee must remit to the Electoral Officer or Deputy Electoral Officer, by 6:00 PM on October 27, 2024:

- a signed *Acceptance & Declaration form* accepting the nomination for no more than one of the positions for which they have been nominated and attesting to their eligibility to be a candidate under the Act.

BALLOT NAME – If you are a nominee and would like your name to appear differently than the way it is written on this preliminary list, please email OneFeather Support at the contact information listed below by **6:00 PM on October 27, 2024**, and notify us of how you would like your name to appear on the ballot. After that date, the ballots will be printed, and no further changes will be possible.

WITHDRAWAL - A candidate may withdraw their candidacy at any time prior to the close of the polls by submitting to the Electoral Officer a written declaration of withdrawal, signed by the candidate in the presence of the Electoral Officer, a justice of the peace, a notary public or a commissioner for oaths. A candidate who withdraws forfeits the candidacy fee and any votes cast for them will be void. The withdrawal form is available on the webpage listed at the bottom of this page.
