MUSQUEAM SANITARY SEWER REPAIR

Musqueam Creek Sanitary Sewer Rehabilitation project is scheduled to begin in the first week of August/2025. This important project is expected to take approximately three months to complete. This is a project needed to continue to provide sanitary services to the community.

To ensure the safety of both community members and construction workers, access to the Musqueam Creek area will be closed for the duration of the construction period.

There may be temporary interruptions to traffic on Stautlo Avenue throughout the course of the work. These disruptions will be managed to minimize inconvenience, and signage information will be provided as needed. No road closures are expected to Stautlo Avenue. There will be no disruptions to sanitary services during construction.

We have included a map showing the location of where the work will take place. We appreciate everyone's understanding and apologize for any inconvenience during construction.

I'M DEEPLY GRATEFUL TO BE PRACTICING ON THE UNCEDED AND ANCESTRAL LANDS OF THE MUSQUEAM PEOPLE. I WAS BORN AND RAISED IN PORT ALBERNI ON MY FAMILY'S EMU FARM, AND I NOW BELONG TO THE VANCOUVER SEA TO SKY MÉTIS ASSOCIATION, WHERE I LIVE TODAY.




MY FIRST JOB WAS AT A GAS STATION OPERATED BY THE TSESHAHT FIRST NATION, WHERE I SAW FIRSTHAND THE IMPACTS OF HEALTH DISPARITIES IN INDIGENOUS COMMUNITIES. THIS EARLY EXPERIENCE PLAYED A SIGNIFICANT ROLE IN SHAPING MY DECISION TO PURSUE MEDICINE AND FOCUS ON COMMUNITY-BASED CARE. I WAS ALSO DIAGNOSED WITH TYPE 1 DIABETES AS A CHILD, WHICH GAVE ME LIVED EXPERIENCE NAVIGATING THE HEALTHCARE SYSTEM AND A DEEP APPRECIATION FOR THE ROLE OF A COMPASSIONATE, KNOWLEDGEABLE PHYSICIAN. I'VE ALWAYS BEEN DRAWN TO THE PRINCIPLES OF TWO-EYED SEEING, INTEGRATING TRADITIONAL HEALING ALONGSIDE WESTERN MEDICINE, AND CARRY THIS APPROACH WITH ME IN MY PRACTICE.

I COMPLETED MY BACHELOR OF SCIENCE, DOCTOR OF MEDICINE, AND FAMILY MEDICINE RESIDENCY AT THE UNIVERSITY OF BRITISH COLUMBIA, MOST RECENTLY TRAINING AT THE SURREY—SOUTH FRASER SITE. I HAVE A PASSION FOR FULL-SCOPE FAMILY PRACTICE AND AM ESPECIALLY INTERESTED IN CHRONIC DISEASE CARE, ADDICTIONS, AND INDIGENOUS HEALTH. COMING FROM A FAMILY OF TEACHERS, I VALUE SHARED DECISION-MAKING AND TAKE TIME TO EXPLAIN THE "WHY" BEHIND EACH TREATMENT PLAN. 








2025 Water St Pilot Map



Call for Musqueam Artists: City of Delta Welcome Pole

Introduction

The City of Delta is committed to taking meaningful steps towards reconciliation. One of those steps on our journey towards reconciliation is a commitment to recognizing the traditional territories of the Musqueam and Tsawwassen peoples, through the installation of two welcome poles, one designed by a Musqueam artist, and one designed by a Tsawwassen artist. By commissioning these Welcome Poles, the City of Delta will be acting on the Truth and Reconciliation Call to Action #57, by educating Delta's staff and broader community on the cultural significance of Delta and Delta's history with Indigenous Nations. The Welcome Poles will signal the City's commitment to building strong, respectful relationship with Indigenous Nations.

This Call for Artists is for Musqueam Indian Band Member artists that are interested in submitting a response to provide one Welcome Pole that will be placed in a prominent location outside Delta City Hall. The exact location on the City Hall grounds, will be determined in collaboration with the artists.

About Delta City Hall

Delta City Hall serves as the administrative center of the City of Delta, providing essential municipal services and governance for the community. As the home of Delta's local government, it houses city council chambers, offices for municipal staff, and public service departments that oversee everything from planning, engineering, finance, and bylaws.

Beyond its role in governance, Delta City Hall is a hub for civic engagement, where residents can access important services, participate in public meetings, and contribute to the decision-making processes that shape the city's future. It stands as a symbol of local democracy, community collaboration, and the city's commitment to excellent service delivery for its residents.

Eligibility & Submission Requirements

Musqueam artists are welcome to respond to this Call, with the following detail to be included:

- Welcome Pole design drawing
- Description of the Welcome Pole's story and connection between the City of Delta and Musqueam Indian Band
- An Artist Biography, including photos of your past work
- The Artist's commitment to provide a secondary art product that is created specifically off the final design, with the intent for digital reproduction. Details of compensation below.

Remuneration

Remuneration will be provided in two separate project deliverables.

- 1) **Welcome Pole Carving and Installation**: The selected artist will be awarded the remuneration for the carving and installation of a pole (The pole / post is envisioned to be approximately 10 feet in height, x 2 feet in diameter, with a flat back). Remuneration includes all materials used, and installation costs. **Remuneration is set at \$35,000**.
- 2) Digital Design The selected artist and the City will then collaborate to finalize a digital design element, for branding purposes, based on the selected Welcome Pole design. The digital design take-off will be remunerated \$5,000. The City can work collaboratively with the artist on solutions to digitize the designs if preferred by the artist.

Ownership

The project will be commissioned by the City of Delta. Ownership of the poles and digital design will also be by the City of Delta.

Honorarium

Artists that submit full and complete responses to this Welcome Pole Call will receive a submission honorarium of \$250 per artist.

Please note that any art submission that was not selected as the finalist will be returned to the artist. The City will not replicate or use those submissions for any future use.


